<p><u>Re-Opening Guidelines:</u></p> <p>Decisions to advance into various phases will be contingent upon the following factors: 1. state/local government re-opening plan, 2. general community COVID rate remains low or trending downward, 3. there are no positive cases on campus in any level of care, 4. testing remains available, 5. the campus has adequate staffing to supervise and monitor the program, service, or area, and 6. there is sufficient PPE and cleaning supplies, and 7. ability to meet federal state, and local safety requirements.</p> <p>The campus re-opening phases for each service area above are independent of each other. Some services are dependent upon state re-opening plans.</p> <p>Each phase progression will be evaluated for a period of at least 14 days for successful implementation and maintenance based on the above factors.</p>
